KTCK'S "DAVE MATTHEWS BAND TEXT TO WIN" CONTEST OFFICIAL RULES

The Station will conduct the The Ticket/KTCK's "Dave Matthews Band Text to Win" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. During the contest period, announcer will randomly prompt listeners to send a text message during the hours of 5:00 AM CST and 7:00 PM CST with the keyword DAVE spelled correctly to 22126 during the Contest Period. All entries must be received by 7:00 PM CST on Friday, February 25th 2022 to be eligible for a chance to win a prize. Winner will then be selected at random through company's online database. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number

4. **Winner Selection.** On or about 7:00 PM CST on Friday, February 25th 2022, Station will select FIVE (5) potential winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within FIVE (5) days of notification or

failure to claim the prize within THIRTY (30) Days of verification as a winner will result in disqualification and forfeiture of the prize.
