## **Secret Contest Rules: Score The Big 4**

The Ticket's "Score The Big 4" Contest Official Rules:

A complete copy of these rules can be obtained by contacting radio station KTCK-AM ("Station"), 3090 Nowitzki Way, during available business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct **The Ticket's "Secret Contest** (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. No purchase is necessary to enter or win. A purchase will not increase your chance of winning. Void where prohibited. All federal, state, and local regulations apply.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number. Void where prohibited by law. Employees of Station, KTCK, LLC and Radio Metroplex, LLC, and their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

- Contest Period. The Contest entry period will begin at 9:00am CT on November 3, 2025 and will run through 11:59pm CT on December 5, 2025 (the "Contest Period").
   The Station's computer is the official time keeping device for this Contest.
- How to Enter.
- Text: Listen to Stations weekdays from 9:00am to 3:00pm CT during Contest Period for Station to announce one (1) of up to sixty (60) rotating Secret Keywords. The keywords will be a "Mascot of the Day" and will be disguised as a Thank You message that will be said on-air at or around the :40 minute mark of each hour during the Contest Period (each a "Contest Round"). For example, the Station may say Listen for the [Mascot of the Day]. When you hear it, you can either text the team name to 22126\* every hour for a chance to win OR you can

enter that hour's team name on this page (the form is below)! There are 6 CHANCES TO ENTER every weekday! Example: "The Mascot of the day are the [Tigers]! Shout out to the [Tigers]!" When Station announces the secret keyword during the Contest Round, listeners should send a text message with the keyword spelled correctly to 22126. All Secret Keywords for all Contest Rounds must be correctly spelled and received into the texting system no later than 11:59pm CT on the same weekday that the Secret Keyword was announced, in order to be eligible to win. Incorrect, misspelled, late, and/or texting system rejected entries will not be entered to win. Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number per secret keyword solicit/Contest Round. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Contest.

• Free Alternate Method of Entry Online: Listen to the Station during a Contest Round. When Station announces the secret keyword during the Contest Round, visit the Station's "Secret Contest" webpage <a href="www.theticket.com/secretcontest">www.theticket.com/secretcontest</a> during the Contest Period, and complete an entry form including providing the Secret Keyword(s) spelled correctly. You must successfully submit the Secret Keyword(s) correctly spelled and your complete and accurate registration information no later than 6:59pm CT on the same weekday that the Secret Keyword was announced in order to receive a valid entry. Incorrect, misspelled, late, and/or system rejected entries due to any technical misfunction will not be entered to win.Limit one (1) entry per person per keyword solicit/Contest Round, regardless of how many email addresses a person may possess and use. Multiple participants are not permitted to share the same email address. Any attempt by any participant to submit more than one (1) entry by using

multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the participant. The "authorized account holder" is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Station and will not be returned. Station reserves the right to contact entrants and all other individuals whose email address is submitted as part of this promotion. No mailin entries will be accepted.

Texting will not increase an entrant's chances of winning. Limit one (1) entry per person per Contest Round, regardless of the method of entry chosen by a listener. Each Contest Round, listeners may either (i) text in an entry into using a mobile device or (ii) enter online, but not both methods.

- Winner Selection. On or about 10:00am CT on Monday, December 8, 2025, Station will select one (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within one (1) day of notification or failure to claim the prize within one (1) day of verification as a winner will result in disqualification and forfeiture of the prize.

  WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE

The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within one (1) day of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. Station and any Sponsors make no representation or warranty about the safety of any prize.
